**OLD BUSINESS:**

No old Business was conducted

**NEW BUSINESS:**

A matter was brought to the floor concerning the actions of a CGSTA/ATA/AIM\_SCTP Coach at the 2019 Kids SCTP /AIM championships. This individual was seen throwing his teams and his personal award in the trash at the awards ceremony. This action was brought to the attention of the SCTP and AIM directors. The Coach was brought into the shoot Office which was being run by Kym Hughes( CGSTA Secretary), Julie Robinson ( CGSTA Treasurer) and Carol Sutton (Shooting Star Office Personnel). Kym Hughes asked the coach if he had thrown his awards away and he responded with a NO. It was then stated to the coach that whoever had committed the action was to come into the office. A minor was brought to the office and freely admitted to throwing away his medal. After a discussion as to why he was sent off with a warning. The coach in question had been found to be lying about his actions in a subsequent letter he submitted to the SCTP national director. With much discussion as to this coaches actions at the entire junior championship shoot ( missing squads, score sheets not being returned to office as sent out etc), the board opted to send him a letter as to inquire to a reply to the actions, with the return of the statement, the board opted to recommend a suspension of this member from the CGSTA. ( Secretary Note: Prior to being able to send out a letter to this member, he had already been told about the impending actions against him and many phone calls ensued from various ATA personnel and their recommendations to not impose any suspensions due to the he said/ she said nature this had now taken on). With the previous Note, any action taken by the board was nulled by an email vote by the board.

The board set its committees for the year at this meeting. All committee positions were filled for the 2019/2020 year

The matter of the state shoot dates for 2020 was brought to the floor. The board discussed the merit of moving the state shoot up one week in June. The discussion centered around the desire of the shooters to have a better chance at cooler weather. Also the earlier date would move the CA state shoot off the same weekend that Utah had started hosting their state shoot on ( Utah opted to being throwing their state shoot on the same week that CA traditionally did).
