CORROSPONDENCE:

Secretary Hughes reported that we had very little correspondence deferring to Chayton Vega for the ATA rule changes.

Chayton Vega reported that the ATA All American point system has upped the number of targets and days that can be thrown and counted for All American points. 1300 targets can be counted as long as your championship event have 450 shooters combined (Singles Handicap and Doubles) and now up to 7 days may be included in the count as opposed to the 1100 targets and 5 days of past years, noting that if you had 450 in 2022 for your state shoot then you will be grandfathered in for 2023 for this year only.

NEW OR REPLACEMENT DIRECTORS:

OLD BUSINESS:

State Shoot recap was discussed with some discussion of changing up the Program of Events for the 2023 State Shoot to include more events and more doubles

NEW BUSINESS:

State shoot dates will be June 20- 25, 2023

The Kids shoot will be on June 17-18, 2023 (SCTP and AIM Championships)

It was brought up that the CGSTA will have to set the voice calls on the 15th.

All help will be accepted.

It was brought up about the targets for the state shoot. It was discussed that shooters wanted to bring back pitch targets (small group of shooters), discussion ensued about how that would affect cost of targets at the 2023 state shoot. With the knowledge that pitch cost more than the Blackouts, depending on the price set to the CGSTA by Kingsburg it could be feasible to see 47+ dollar targets. This will be discussed at the next meeting after the meeting with KGC. We also talked about the color of targets that we could present at the State Shoot.

Committees were set for the 2022-23 shoot year.

Discussion was brought up that the Class Singles Event does not have to be 200 birds. Everyone loathes 200 singles. With the new ATA rules in place it was discussed that we could change up our program of events and make the Class Singles event 100 birds and offer a few more doubles events (Treasurer Robinson voiced her displeasure of doubles- it was noted), we could also change

up the Tuesday shoot line up and add an event can call it a preliminary day. We will visit this on our next meeting when we set the price for targets and we will finalize the state shoot program.

Discussion was also passed around about bringing back a Winter Chain type of shoot, nothing was decided but each director said that they would think on options to give at the next meeting.
